Sub: Notifying Ph.D. Regulations of Joy University – reg.
Ref: University Grants Commission (Minimum Standards and Procedures for Award of Ph.D. Degree) Regulations

Referring to the subject matter and the UGC Regulations on minimum standards and procedures for award of Ph. D., degree, 2022, further instructions issued in this regard from time to time, the Joy University Ph.D., regulations, 2024 is hereby notified.

This regulation will apply to the full-time and part-time Ph.D., programmes of the University and shall come into force with immediate effect. Any modifications made by the UGC from time to time in its Ph.D., regulations, with due notification by the University shall be applicable to these Ph.D., regulation.

On and after the coming into force of these Regulations, any other regulations in force governing Doctoral Degree Programme, prior to these regulations in the university shall stand repealed.

In exceptional cases not covered in the Ph.D., regulations 2024 or arising out of the interpretation of this regulation, the decision of the Chancellor of Joy University shall be final and binding.

Subject: Grant of Stipend/Fellowship for Full-Time Ph.D. scholars - Reg.
Ref: Chapter X (Clause 31) of JU Ph.D., Regulations, 2024

As per the provisions contained in the Joy University Ph.D., Regulations cited at reference notified in accordance to the UGC – minimum standards and procedures for award of Ph. D. degree regulations, and as per the approval of the Competent Authority, it has been decided that the monthly stipend applicable to the scholars enrolled for full-time Ph.D., programmes at JU will be granted the monthly fellowship/stipend @ Rs.15,000/-. Grant of monthly stipend is subject to the adherence to the following terms and conditions.

1. This stipend will be granted to research scholars contingent upon their satisfactory performance in research activities and the fulfillment of departmental responsibilities.
2. Submission of a monthly progress report (Annexure-1).
3. Completion of designated teaching assignments
4. Actively engage in delivering research seminars and contributing to research publications.
5. Fulfillment of examination duties for both mid-term and comprehensive assessments.
6. Compliance with mandatory biometric attendance requirements.
7. Coordination and support for departmental and school events.
8. Adherence to the leave policies as stipulated by the Joy University rules and regulations.
9. Any other terms, conditions and regulations being notified in this regard from time to time.
